

CAA Insurance Story Giveaway – Terms & Conditions

Eligibility:

This giveaway is open to legal residents of Saskatchewan only who are 18 years of age or older at the time of entry. Employees of CAA Saskatchewan and their immediate family members are not eligible to participate. This giveaway will be delivered in English only.

How to Enter:

To enter, submit your home or auto insurance story using the official entry form sent via email. Stories may describe experiences with CAA Insurance or other insurance providers. Limit one entry per person. No purchase necessary.

Giveaway Period:

The giveaway begins on May 26, 2025 and ends at 11:59 p.m. CST on June 9, 2025. Entries submitted after the deadline will not be eligible.

Prize Details:

Five (5) winners will each receive one (1) Sobeys gift card valued at \$100 CAD. Gift cards are not transferable or redeemable for cash.

Winner Selection:

Winners will be selected by random draw from all eligible entries received during the giveaway period. Odds of winning depend on the total number of eligible entries received. The draw will take place on or before June 13, 2025. Winners will be contacted by a CAA Saskatchewan representative via email from **marketing@caask.ca**, using the address provided in their entry. Selected winners must correctly answer a time-limited, mathematical skill-testing question to be declared a winner and claim the prize. To claim their prize, winners must respond within **5 business days** of being contacted. If a selected winner does not respond within 5 business days, an alternate winner will be selected, and this process will continue until all prizes are awarded.
