

# CAA Saskatchewan, “Nominate A Hero” Giveaway Contest – Terms & Conditions

## Sponsor:

This giveaway (the “Giveaway”) is sponsored by **CAA Saskatchewan**, located at 200 Albert Street North, Regina, SK, S4R 5E2 (“Sponsor”). For any questions regarding the Giveaway, please contact [marketing@caask.ca](mailto:marketing@caask.ca).

## Eligibility:

The Giveaway is open only to legal residents of **Saskatchewan**, Canada who are **eighteen (18) years of age or older** at the time of entry. Void outside of Saskatchewan and where prohibited or restricted by law. Employees, officers, directors, representatives, and agents of Sponsor and its affiliates, subsidiaries, advertising and promotion agencies, and their immediate family members (spouse, parent, child, sibling, and their respective spouses, regardless of where they reside) and those living in the same household (whether related or not) are not eligible to enter or win. The Giveaway will be conducted in English only.

## How to Enter:

To enter the Giveaway, an individual (the “Entrant”) must complete all of the following steps during the Giveaway Period (defined below):

1. **Like** the official Giveaway post on Facebook or Instagram (as applicable).
2. **Comment** by tagging one (1) person (the "Nominee") and stating why they deserve to win.
3. **Share** the Giveaway post to their own public Facebook story or Facebook feed and tag the **CAA Battery Depot** Facebook page at <https://www.facebook.com/ReginaBatteryDepot>
4. **Submit the official entry form** via the link provided in the post caption. Only entries with a completed form will be considered valid.

**Limit one (1) entry per person.** Multiple entries, automated entries, entries submitted by bots, or entries that do not comply with the submission requirements will be disqualified. No purchase necessary.

### **Giveaway Period:**

The Giveaway begins at **9:00 a.m. Central Standard Time (“CST”) on May 6, 2025** and ends at **11:59 p.m. CST on May 13, 2025** (“Giveaway Period”). Entries submitted after the Giveaway Period will not be considered.

### **Prize Details:**

There will be **one (1) winning entry** selected. The prize is as follows:

- The Nominee (the tagged individual identified in the entry) will receive **one (1) free car battery and (optional) standard installation service with a combined maximum value of \$350 CAD**, redeemable **only at CAA Battery Depot, located at 200 A Albert Street, Regina, SK.**
- The Entrant (the person who submitted the valid entry) will receive **one (1) \$100 Battery Depot voucher**, also redeemable **only at CAA Battery Depot, 200 A Albert Street, Regina, SK.**

Prize must be accepted as awarded. No substitutions, cash redemption, or transfer of prize permitted, except at Sponsor’s sole discretion. All federal, provincial, and municipal taxes, if any, are the sole responsibility of the prize winner.

### **Winner Selection and Notification:**

On or about **May 20, 2025**, one (1) eligible entry will be selected by random draw from all valid entries received during the Giveaway Period. The odds of winning depend on the number of eligible entries received.

The selected Entrant will be contacted via the email provided in the entry form. In order to be confirmed as the winner, the Entrant must:

- Respond to the notification email within **five (5) business days**;
- Correctly answer a time-limited, mathematical skill-testing question without assistance;
- Provide any requested documentation to verify eligibility;
- Sign and return a declaration of compliance and a liability/publicity release form within the time specified by Sponsor.

Failure to comply with these requirements may result in disqualification and selection of an alternate winner at Sponsor's sole discretion.

### **Prize Fulfillment:**

Both the battery installation and the voucher must be redeemed **in person** at CAA Battery Depot in Regina. No delivery, cash equivalents, or substitutions will be offered. Unclaimed prizes may not be re-awarded. Sponsor shall have no liability for any lost, misdirected, or unredeemed prizes.

### **Publicity and License Grant:**

By entering the Giveaway, Entrants and Nominees (if selected) consent to the use of their name, social media content, and story submission by Sponsor for promotional purposes in any media, worldwide, without further compensation or notice. Sponsor reserves the right to edit any submission for length, clarity, or compliance with Sponsor's content standards.

### **Privacy:**

Personal information collected from Entrants will be used solely for the purpose of administering the Giveaway and, where consent is provided, for marketing purposes. All personal information will be handled in accordance with Sponsor's [Privacy Policy](#).
